The Riverton Library and Free Reading Room was founded in 1899 with its first collection located in the Christ Episcopal Church Parish House. In 1900 The Riverton Free Library Association was established and incorporated with a Board of fifteen Trustees. The library moved its collection to a building across the street to 306 Main Street after a generous community member, Sarah Morris Ogden, donated one of her residences for the library in memory of her late husband, Edward H. Ogden, Riverton's first mayor.

Over the years the library has flourished with increasing patron support for its programs, fundraising events, and endowments. In 1958 and 1991, the library celebrated building additions to enhance service, especially to the Riverton and Palmyra communities. In 1986 and again in 2009, the Board collaborated with the Historical Society of Riverton to scan local, historic newspapers then have them digitized, providing greater access to Riverton and Palmyra history. The Riverton Free Library Association created its own, first website in 2002 to help fulfill their mission of being an "integral, valuable community resource every day." In 2003 the library became a branch of the Burlington County Library System.
